



- · Computers for personal (not business) use.

- · Computer parts, like keyboards and monitors, when not sold with a CPU.
- · Storage media, like flash drives and compact discs.
- · Individually purchased software.
- · Video game consoles.

History of Lions Volunteer Blind Industries 2000 - 2009

In 2000, LVBI participates in prototype development of IPFU (Improved Physical Fitness Uniform) pant to replace fleece sweatpants for the Army. LVBI faces the challenge of 500,000 government credit card buyer's by-passing priority on blind-made products by purchasing direct from other commercial vendors in 2000.

In 2001, LVBI celebrates 50th anniversary! Initiates "Project Paycheck" annual employment scholarship program.

In 2002, TNVOL Manufacturing & Services, Inc. is established as a related non-profit company whose sighted employees assist LVBI blind workers in manufacturing JWOD (Javits Wagner O'Day Act) products.

In 2003, LVBI opens a Factory Direct showroom and mattress outlet store. A loss of financial support from the Division of Rehabilitation Services forces a reduction in force for rehabilitation personnel.

In 2004, a strengthened partnership from government customers with additional items: mattresses, various styles of helmet covers for Army/Marines. LVBI marketed rehabilitation services to surrounding states to offset loss of Tennessee funds.

History of Lions Volunteer Blind Industries (con't) 2000 - 2009

In 2005, LVBI implemented Strategic Planning Process to meet vision. Increases involvement with Package Room vendors to federal customers with resulting sales jump. Secured LCIF grant (\$150,000) for new sewing equipment.

In 2006, returned NIB (National Industries for the Blind) ratio to 76.35% direct blind labor after a year of surge protection due to accelerated deliveries. Record sales for mattress department (\$3 million +)! Introduce corporate partnerships to "Project Paycheck" program. Record sales year for LVBI (\$11.5 million).

In 2007, LVBI posts record sales for 57-year history! Revenues approach \$15 million!!! LVBI hosts first annual "American Dream Team" fund raiser to support "Project Paycheck" scholarship costs of \$310,000.

In 2008, LVBI expands its employment commitment to the disabled community by focusing the mission of TNVol Mfg. toward employment of people with severe disabilities, and affiliating that company with NISH (National Industries for the Severely Handicapped) in 2008.

In 2009 Fred Overbay retires after 15 years with LVBI. Don Britton is promoted to Executive Director. LVBI commits to service employment through the employment of a Director of Information Technology and a Call Center Project Manager.


